Q&A after speech

Raymond Chen-En SUNG acquired his LL.B. & LL.M. from the College of Law, National Taiwan University, and M Juris from St Catherine' s College, Oxford. Over the years he has been working as a legal adviser to the delegation of the Fishery Agency and the Foreign Ministry of Taiwan, negotiating the founding instruments of regional fisheries management organizations. He has also been a researcher and executive secretary of the Tang Prize Selection Committee for Rule of Law since its inception in 2013. He is also a proliferate writer of column articles and op-eds in Taiwan, addressing issues relating to Taiwan' s status, international law and politics, in a wide range of topics, bringing him to probe deeper into Taiwanese history, identity and democracy.

於台灣大學法律學院取得法律學士、法律碩士後，前往英國牛津大學讀書，現為英國牛津大學博士候選人，專長為國際公法、國際海洋法、國際爭端解決。2006年回台後，曾任 ROC 對外漁業合作協會(OFDC)兼職法律顧問，與外交部「我國參與國際漁業組織之策略研究專案小組」研究人員，期間曾參與多項台灣在區域

性漁業管理組織的入會談判，具備涉外談判經驗，也第一手見證中國在國際組織對台灣的打壓。2013 年交卸法律顧問工作後，積極參與公民社會並著述不斷，其有關台灣主權、海域爭端、國家安全法制與對外關係的文章，散見期刊、報章與網路媒體。
